NEWS FROM THE ELDERS

Creating a Mission Opportunity and Strengthening Relationships at St. Paul

The “St. Paul 2030” document, put together mainly by Pastor Alms, Chris Parsons, and Aaron Nelson, lays out our congregational direction over the next 5 years. Unifying our direction will indicate our priorities and will allow St. Paul to develop plans and set goals to achieve those outcomes. Three outcomes were named:

- 1) enhancing St. Paul School,
- 2) expanding our outreach programs, and
- 3) strengthening St. Paul congregation’s ability to help its members grow and develop spiritually.

The two outcomes that the elders have fully embraced and will take responsibility for are expanding our mission outreach programs and strengthening St. Paul congregation’s ability to help its members grow and develop spiritually.

Expanding our mission outreach means that St. Paul would partner with other LCMS churches and organizations in order draw new people to Christ and connect them with our Lutheran community. To this end, Pastor Alms intends to meet and brainstorm with our Circuit pastors and other Baltimore area pastors, engage with the Southeastern District to learn about best practices, support, and funding that may exist, and convene a small committee (2 or 3 persons) from St. Paul to engage with others in the Baltimore area in developing/working on/creating one mission opportunity by the fall of 2026.

Developing a Relational and Social Fellowship Ministry would direct/employ the vicar to lead/expand the youth program, create and lead a young adult ministry that would include Bible study and social events, and use volunteers to create at least one other fellowship group at St. Paul, perhaps one centered around the needs of young men.

ST PAUL SUPPORTS : OUR MISSIONARIES IN ROMANIA

Greetings from Romania! We appreciate your patience in waiting for this newsletter; everything has been very hectic, and so we haven't had any time to write one. But we will tell you why that was the case now! Essentially, we have arrived in Romania and are in the process of settling into our new country.

November was filled with preparations for moving abroad. We sold our cars, figured out how our phones would work, booked airline tickets, and spent days slogging through the bureaucracy required to get the documents we needed for living in Romania. We also got to spend time with our families, celebrating Thanksgiving and saying goodbye.

On November 30th, we left the United States, flying from Chicago to Frankfurt and then finally Bucharest (the capital of Romania). After about thirty hours of travel and sprinting for a flight, we rested in Bucharest for a day, and then met with our immigration lawyer. He is helping us to legally stay here after the 90-day limit is over via a residency permit.

After that, we traveled by train to Brasov. Melissa Pflug, the missionary care coordinator for the Eurasia region (who we would be floundering without!) met us at the train station and drove us to our new home. She also very kindly stocked our fridge and made sure we had everything we would need to survive our first few days.

Then illness hit! Ella was struck by an awful flu-like illness and Ben became similarly infected not long after. The illness debilitated each of us for about a week, and so we are only just recovering. Our exploration and settling in has been on pause due to the illness, but we are excited to jump into it now that we are both feeling better.

Everything Is New Being in a new country is very exciting! Everything that we previously assumed about culture and living is very different here, and we are building our new routines and finding our new favorite places. Luckily for us, Romanian food is very delicious (at least what we got to try before we got sick)! The Christmas tree in the city center of Brasov. It is the brightest we've ever seen! We are also getting used to walking a lot more places, and it feels good to lead a less sedentary lifestyle and enjoy a more walkable community. It is strange to be without a car, but the driving here is a lot to get used to, so, we are also grateful that we do not have to navigate the roads yet.

FORO season is wrapping up! I supported the DR FORO in September and Stan is connected to all of them throughout the region. They're content, happy, and always ready to lend a hand, as they did with our first flat tire on a major street with cars zipping past. Plus, they're open to hearing the truth in God's word. Eyeglass Clinic

I hosted a MOST Ministries team who provided an eyeglass clinic at a local congregation, Pueblo Nuevo, and its mission outpost, Cien Fuegos. (Yes, you read that right, church plants are starting church plants!) 573 people were reached with the gospel message, eye health information, an eye exam, and 784 glasses were distributed. This not only physically blessed the people of the community, but also exposed them to the church and the clear gospel. This generated enough contacts and interest that the mission in Cien Fuegos is now celebrating the Divine Service weekly.

A View from the Regional Business Managers Desk

What exactly is a FORO? It's a collaborative effort between LCMS Districts, Congregations, Individuals, RSOs, and the LWML, along with local communities, to organize programs and budgets that support spreading the gospel, planting Lutheran churches, and showing mercy. Throughout the region, we have 13 FOROs supporting 42 church plants. We hold planning meetings in the Spring and Fall. If you're interested in experiencing missionaries working with the local people and learning about FOROs consider "shadowing a FORO."
